Session 1

Framing Current Scholarly Communications Challenges and Opportunities for Africa

Our opening session will set the stage for this global conversation, with the African continent as its special focus, as we all continue to bridge the gap between the global North and South. We will begin with two framing overviews of societal challenges for different regions in the African continent, particularly in the sphere of scholarly communication and access to information - challenges that are poorly understood by others in the information chain. We will then hear about two significant efforts aimed at redressing some of these challenges: (1) the building of the African Open Science Platform, which aims to position African countries at the heart of scholarly discourse; and (2) the influence of colonization on access to information and efforts to redress the current, long-lived situation. After a break, there will be a far-ranging discussion between the speakers and the audience.

Session 2

Equity and Inclusion in the Journal Ecosystem: Access, Discovery and Exploration

Coordinated by Buhle Mbambo-Thata, University Librarian - National University of Lesotho, Lesotho, South Africa

Journals are a rich source of diverse and up-to-date content. Journals have the potential to be essential information resources for researchers searching for information on minority and marginalized groups and languages. However, journals emanating from minority groups, languages and marginalized populations are often not accessible nor discoverable, and therefore not cited. In what ways can journals amplify marginalized voices? How can librarians and information centers enable their readers and researchers to discover and use rare journals? What is the role of publishing and hosting organizations in sustaining such journals?

This session will examine issues of equity, inclusion, and decolonization as levers in a discussion of mainstreaming marginalized journals. What could be some innovative ways of keeping such journals going? How can small journals of minority languages be profiled and made accessible? This session will explore these and other issues related to discoverability, access, and sustainability of journals from marginalized languages and communities. The session will be led by library leaders, researchers and journals publishing platforms who will address issues of inclusion and equity in the journal ecosystem.

Countless non-profit and government reports are disappearing and physical artifacts are being lost. We underscore the renewed urgency to safeguard and reimagine Africa's invaluable knowledge and culture. Together, these talks illuminate the path forward for Africa's academic, scientific and cultural resurgence in the global arena.
